What is this product?

ETFS G10 vs USD Multi Strategy FX Basket is designed to provide investors with access to four Objectives:

different currency methodologies combined into one basket product by tracking the G10 Multi FX Enhanced Basket Index (USD) (the "Index"). Each methodology is given an equal volatility adjusted weight. The product reflects the performance of the Index such that, for example, if the Index were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the Index were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments).

The four different methodology Indexes that comprise the Index are as follows:

(i) the G10 Risk Adjusted Carry Basket Index (USD)


(ii) the G10 Equity Signal Basket Index (USD)

(iii) the G10 REER Valuation Basket Index (USD)

(iv) the G10 Market Positioning Basket Index (USD). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Morgan Stanley & Co. International plc. The payment obligations of the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.
