This Key Information Document (KID) is issued by the manufacturer of the product, SL Capital Partners LLP, a firm authorised and regulated by the Financial Conduct Authority in the United Kingdom.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Ordinary shares in a closed-ended investment company registered in Scotland, with Investment Trust status, which is listed on the London Stock Exchange. Shares of Standard Life Private Equity Trust plc (the "Company") are bought and sold via markets. At any time, the price you would pay to acquire a share will normally be higher than the price at which you could sell it. The price may be at a premium or discount to the net asset value of the Company.

The Company's investment objective is to achieve long-term total returns through holding a diversified portfolio of private equity funds and direct investments into private companies alongside private equity managers ("co-investments"), a majority of which will have a European focus. Private equity funds, in turn, make investments into private companies and the investment returns made by the Company are determined by the performance of these underlying investments. The Company's policy is to invest in approximately 50 "active" private equity fund investments which are selected to provide a broadly diversified portfolio by country, industry, sector, maturity and number of underlying investments. The Company may invest up to 20% of its total assets in co-investments. To maximise the proportion of invested assets it is the Company's policy to follow an over-commitment strategy by making fund commitments which exceed its available cash and committed credit facilities. The Company has a borrowing facility which is used from time to time for short term working capital purposes rather than long term structural gearing.

The Company's aim is to pay quarterly dividends with a minimum annual dividend of 12.8 pence per share. The intention is to maintain the real value of this dividend, and grow it at least in line with inflation, in the absence of unforeseen circumstances.

The product has no maturity date and can only be wound up with the consent of shareholders. SL Capital Partners LLP cannot wind up the Company.

What are the risks and what could I get in return?

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Company is not able to pay you.



We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact your ability to sell your shares.



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

What are the costs?

The 'other ongoing costs' comprise the following:

- 1.19% of direct costs of the Company (including the Annual Management Charge of 0.95% of net assets)
- Other ongoing costs includes 4.31% of indirect costs incurred in the underlying portfolio investments. These indirect costs comprise carried interest of 2.57%, underlying management fees of 1.44% and other expenses of 0.30%.

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years. You may buy or sell shares in the product, without penalty, on any normal business day.
