What is this product?

WisdomTree Long NOK Short EUR is designed to enable investors to gain exposure to Norwegian Krone ("NOK") relative to Euro ("EUR") by tracking the MSFX Long Norwegian Krone/Euro Index (TR) (the "Index"), which aims to reflect the performance of a position in forward contracts which are rolled on a daily basis. The product provides a long exposure to NOK relative to EUR. For example, if NOK were to rise in value relative to EUR, the Index (tracked by the ETC) would rise in value. Conversely if NOK were to decrease in value relative to EUR, the Index return also includes a component based on the interest rate differentials, reflecting the difference between the NOK and the EUR exchange rates. The Index is a total return Index, which means that it also provides a collateral yield. The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Morgan Stanley & Co. International plc. The payment obligations of the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.

Intended retail investor:

The product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering an exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

The summary risk indicator is a guide to the level of risk of this product compared to other products.
