# What is this product?

Type This product is a closed-ended investment scheme, trading on the Main Market of the London Stock Exchange

(within the Premium segment).

Strategy This product aims to provide its shareholders with regular, sustainable dividends and to generate capital appreciation

through investment, directly or indirectly, in business-essential, revenue producing (or cost-saving) equipment and
