What is this Product?

The information contained in this document and the methodologies for calculating risks, costs and potential returns are prescribed by EU rules.

The "Company" is a closed-ended investment company whose shares are listed on the London Stock Exchange's Main Market. The Company is also an alternative investment fund as defined under the Alternative Investment Fund Managers Directive ("AIFMD"). The Company's shares are available to the general public.

The objective of the Company is to seek capital appreciation by investing predominantly in equity securities of U.S. companies.

The product is suitable for institutional investors and retail investors who are prepared to take on some risk of loss to their original capital to achieve a higher potential return, who plan to stay invested for at least five years and who hold the product as part of a diversified portfolio.

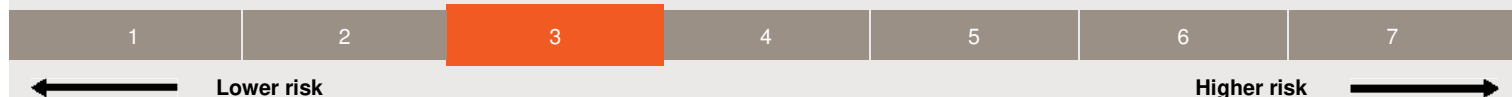
The Company may borrow to purchase assets for the Company. Any borrowing may magnify any gains or losses made by the investment company.

There is no fixed maturity date. The Company may not unilaterally or automatically hold them in treasury or terminate shareholdings of investors in the Company. However, the Company may buy-back its shares at market prices and cancel them.


The shares of the Company are bought and sold via markets. At any given time on any given day, the price you pay for a share may be higher than the price at which you could sell it.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 5 years. If you sell the shares at an earlier stage the actual risk can vary significantly, which may mean you get back less.

 We have classified this product as 3, which is a medium low risk class. This rates the potential losses from future performance at a medium low level, and poor market conditions are unlikely to impact the amount you could get back.

What are the risks and what could I get in return? (continued)

This table shows the money you could get back over the next 5 years, under different scenarios, assuming that you invest £10,000. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past and are not an exact indicator of what your returns will be. Your returns will depend on how the market performs and how long you keep the investment. The stress scenario shows what you might get back in extreme market circumstances. It does not take into account the situation where you can lose the entire value of your investment, which is possible.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the Company itself, for three different holding periods. The figures assume you invest £10,000. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

The recommended minimum holding period of 5 years has been selected for illustrative purposes only and reflects the long-term nature of the Company's investment objectives, but investors may elect to sell their shares on the market at any time without penalty by the Company. The value of shares and the income derived from them (if any) may go down as well as up, and investors may not get back the full value of their investments. Whilst the shares are traded on the London Stock Exchange's Main Market, it is possible that there may not be a liquid market in the shares and investors may have difficulty selling them.
