### What is this product?

#### Type:

#### Objectives:

WisdomTree Physical Precious Metals is designed to enable investors to gain a simple and cost-efficient way to access the precious metals market by providing a return equivalent to the movements in the spot prices of four precious metals less the applicable management fee. The product reflects the performance of the underlying spot price such that, for example, if the spot price were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the spot price were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. This ETP is backed by physical allocated Precious Metal held by an independent custodian, HSBC Bank plc. Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery for gold and silver and the London Platinum and Palladium Association's (LPPM) rules for Good Delivery for Platinum and Palladium can be accepted by the custodian. Each physical bar is segregated, individually identified and allocated.

#### Intended retail investor:

The product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering an exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.
