WisdomTree Agriculture Longer Dated is designed to enable investors to gain an exposure to a total return investment in agriculture commodities futures contracts by tracking the Bloomberg Agriculture Subindex 3 Month Forward (the "Index") and providing a collateral yield. The product reflects the performance of the Index such that, for example, if the Index were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the Index were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments).
