### What is this product?

#### Type

English law governed, certificated, registered, collateralised debt security.

#### Objectives

WisdomTree Palladium 2x Daily Leveraged is a fully collateralised Exchange-Traded Commodity (ETC) designed to provide investors with a leveraged exposure to Palladium . The ETC provides a total return comprised of 2 times the daily performance of the Solactive Palladium Commodity Futures SL Index (SOLWSPA1), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Solactive Palladium Commodity Futures SL Index rises by 1% over a day, then the ETC will rise by 2%, excluding fees. However if the Solactive Palladium Commodity Futures SL Index falls by 1% over a day, then the ETC will fall by 2%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

#### Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product however, the final maturity date is 30 November 2062. The Issuer is entitled to terminate this product unilaterally.
