What is this product?

This is an investment trust.

Investment objective and policy

The Company's investment objective is to invest in mid cap equities with the aim of providing a total return in excess of the FTSE 250 (ex-Investment Companies) Index.

The strategy is to invest principally in the investment universe associated with the benchmark index, but with anelement of leeway in investment remit to allow for a conviction-driven approach and an emphasis on specificcompanies and targeted themes. The Company may also invest in other collective investment vehicles wheredesirable, for example to provide exposure to specialist areas within the universe. The Company may hold up to 20% of its portfolio in equities and collective investment vehicles outside the benchmark index. The Manager has adopted a unique and consistent investment process, taking a stock specific approach with an emphasis on dynamic growth companies. Sector weightings play a secondary role, resulting naturally from stock selection. Fundamental research and engagement with investee companies forms the basis of each investment decision taken by the Manager.

The Company will predominantly invest in companies from the FTSE 250 Index, but may hold up to 20% of its portfolio in equities and collective investment vehicles outside the benchmark index.


The Company has the ability to use gearing for investment purposes up to 25% of total assets.

Intended retail investor

The Company is intended for retail and institutional investors.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of market movements. The risk indicator assumes that you keep the product for 5 years. The risk is considered to be higher if the holding period is shorter.

The risk category was calculated using historical performance data and may not be a reliable indicator of the Company's future risk profile.

We have classified this product as 6 out of 7, which is the second-highest

risk class.

The Company is in this category because it can take risks in search of higher rewards. This category rates the potential losses from future performance at a "medium" level, and poor market conditions will likely cause shareholders to lose money.

The following factors serve to increase risk and may lead to higher volatility in the Company's share price: it invests solely in the securities of one country; it invests in a relatively concentrated portfolio; it invests in smaller companies which may be less liquid than larger companies; it may use derivatives for specific investment purposes; and it may borrow (or "gear") to purchase assets.

Credit risk

The Company has no significant exposure to credit risk. None of the Company's investments represent more than 10% of its net asset value.
