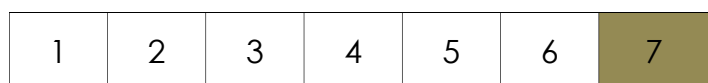

You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

TYPE:	The Company is a closed-ended investment company incorporated in England and Wales. The product consists of subscription shares of nominal value 0.1 pence each in the capital of the Company that are admitted to the standard segment of the official list of the Financial Conduct Authority and to trading on the London Stock Exchange plc's main market for listed securities (standard segment).
OBJECTIVES:	To provide the holder of each subscription share with the right (but not the obligation) to subscribe for one ordinary share on exercise of the rights attaching to the subscription shares and on payment of the subscription price, which 161 pence (being the unaudited published NAV per ordinary share as at the close of business on 15 February 2021, plus a one per cent. premium to such NAV per ordinary share, rounded up to the nearest whole penny). Notice of the exercise of the subscription share rights may be given on the last business day of each calendar quarter commencing on 31 May 2021 and finishing on the last business day in February 2023, after which the subscription share rights will lapse except in the circumstances set out in the prospectus in respect of the subscription shares.

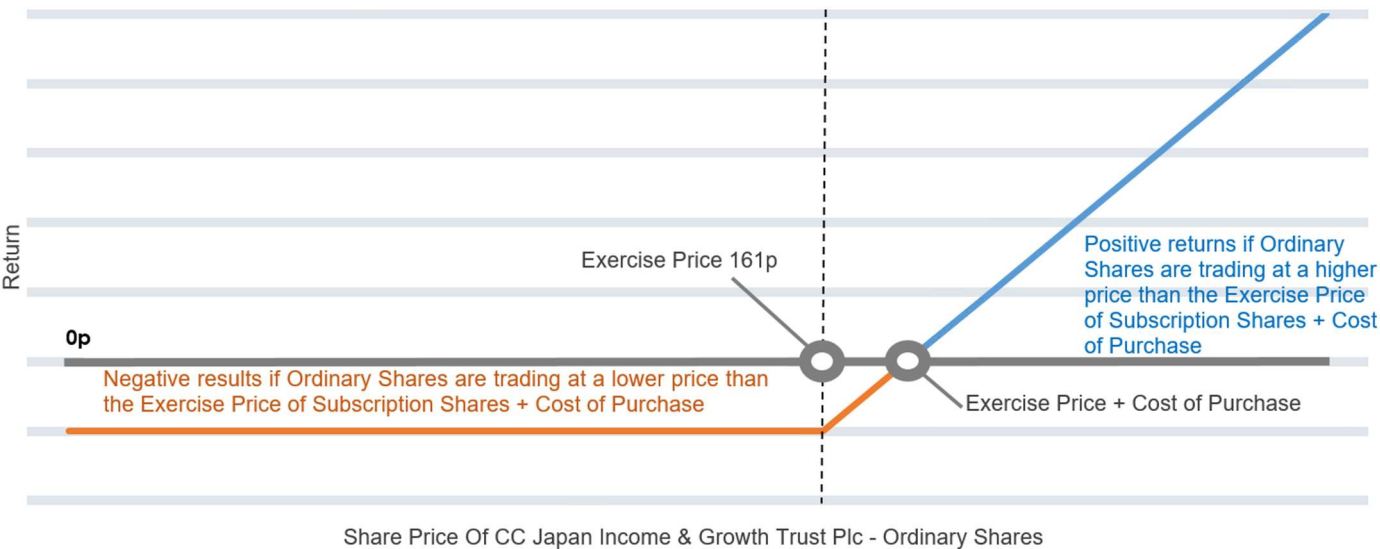
