### What is this product?

#### Type:

Debt security

#### Objectives:

WisdomTree Physical Gold - GBP Daily Hedged is designed to enable investors to gain exposure to the gold spot price with a daily currency hedge against movements in the GBP/USD exchange rate by tracking the MS Long Gold British Pound Hedged Index (the "Index"). The product reflects the performance of the underlying spot price such that, for example, if the spot price were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the spot price were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. This ETP is backed by physical allocated Gold held by an independent custodian, JPMorgan Chase Bank, N.A. and, in order to gain the currency hedge, swaps with Morgan Stanley & Co. International plc. The payment obligations of the swap counterparty to the Issuer are settled in physical gold which is also held in a segregated account with the custodian. Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery for gold and silver can be accepted by the custodian. Each physical bar is segregated, individually identified and allocated.

#### Intended retail investor:

The product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering an exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early or later stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified the risk classes of the underlying investment strategies as 4 out of 7

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the performance.

Be aware of currency risk. If the trading currency is different to the base currency, you will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
