What is this product?

Type: Objectives: This product is a venture capital trust.

The company aims to achieve long-term capital and income growth and to generate tax-free capital and income distributions.


- The company invests in a diversified portfolio of growth-orientated companies across a broad range of industries, with a particular emphasis on companies whose shares will be traded on AIM (the Alternative Investment Market).
 Investments will also be in companies whose shares are traded on ISDX and unquoted companies.
- The company's portfolio is managed in order to meet the investment requirements of Section 274 of the Income Tax Act 2007 ('s274') that, inter alia, requires at least 70% of the investments to be qualifying holdings. Subject to maintaining a prudent margin of safety over the 70% level, the company's remaining assets may be invested in cash or money market deposits, fixed interest securities, unit trusts or UK listed securities without regard to the market capitalisation of such companies.
- The company is permitted to borrow up to 15% of its net assets (115% under the commitment and gross ratios). The company is permitted to have additional leverage of up to 100% of its net assets, which results in permitted total leverage of 215% under both ratios.
- Shares in the company are bought and sold via markets. Typically, at any given time on any given day, the price investors pay for a share will be higher than the price at which investors could sell it.

Intended investor:

This product is intended for investors who are willing to invest for a medium to long term and who plan to stay invested for at least 5 years. Investors should be prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return.

Maturity: This product has no maturity date.

What are the risks and what could I get in return?
