WisdomTree Platinum 2x Daily Leveraged is designed to enable investors to gain a "leveraged" exposure to a total return investment in platinum futures contracts by tracking the Bloomberg Platinum Subindex (the "Index") and providing a collateral yield. A daily leveraged long exposure futures contracts by tracking the Bloomberg Platinum Subindex (the "Index") and providing a collateral yield. A daily leveraged long exposure means that the product is designed to reflect two times the daily percentage change in the Index.
