What is this product?

Type

This is a closed-ended investment company incorporated in Guernsey that qualifies as a real estate investment trust.

Investment objective

The investment objective of the Company is to provide shareholders with an attractive level of income together with the potential for income and capital growth as a result of its investments in, and active management of, a diversified portfolio of UK commercial real estate.

The Company invests principally in the three main UK commercial real estate sectors of office, industrial and retail, and may also invest in other sectors including, but not limited to, residential, leisure, healthcare and student accommodation. Relatively low level gearing is used to enhance income and total return for shareholders with the level dependent on the real estate cycle and the outlook for future returns. The Company benefits from various tax advantages offered by the UK real estate investment trust (REIT) regime.

The Company is valued with reference to the net asset value of the underlying assets. Shares in the Company are traded on the

London Stock Exchange and bought and sold in the market.

Typically, at any given time, on any given day, the price you pay for a share will be higher than the price at which you could sell it. The return to an investor is dependent on the performance of the share price, which may rise and fall in the market and which is largely determined by the performance of the underlying investments. The Company calculates a net asset value on a quarterly basis and announces it to the market. The net asset value per share represents the value of the Company's assets less liabilities, divided by the number of shares in issue. The Company is valued with reference to the value of the underlying assets.

The Company borrows for investment purposes. This will magnify any gains or losses made by the Company.

Intended retail investor

An investment in the Company may be suitable for professionally-advised retail investors. An investment in the Company may also be suitable for retail investors who are financially-sophisticated, non-advised retail investors who are capable of evaluating the risks and merits of such an investment and who have sufficient resources to bear any loss which may result from such an investment.

What are the risks and what could I get in return?

Summary risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of market movements.

We have classified this product as 4 out of 7, which is a medium risk class. The Company is in this category because it can take higher risks in search of higher rewards. This category rates the potential losses from future performance at a "medium" level, and poor market conditions could cause shareholders to lose money.

The Company will invest solely in property located in the UK. This can carry more risk than investments spread over a number of countries. The performance of the Company would be adversely affected by a downturn in the property market in terms of capital value or a weakening of rental yields. The Company invests in real estate which may be viewed as a higher risk and illiquid investment and may, therefore, be adversely affected by a decrease in market liquidity for the assets in which it invests.

Costs over time

How long should I hold it and can I take money out early?
