# WHAT IS THIS PRODUCT?

The product is an authorised closed-ended investment company incorporated with limited liability in Guernsey. The product is supervised by the Guernsey Financial Services Commission and is listed on the main market of the London Stock Exchange.


**OBJECTIVES** 

The product aims to achieve a positive total annual return, after all expenses, of at least twice the Bank of England base rate. The product invests directly in an actively managed portfolio of different asset classes, such as shares, other securities with similar features to shares eg convertible bonds (debt which may be exchanged for shares), government and corporate debt (bonds), collective investment schemes and closed-ended investment schemes (funds) and cash. The product invests across a broad range of assets, geographies and sectors in order to achieve its objective and these will change over time to reflect the risks and returns identified by Ruffer across global financial markets, with an underlying focus on capital preservation. The product may use derivatives for efficient portfolio management purposes only, for example to attempt to offset potential losses that may be incurred by other investments made and to manage the product's exposure to currencies other than Pound Sterling. The product aims to distribute available income every six months. The return achieved by the product will be dictated by the movement of the share price of the product on the London Stock Exchange. The product has no fixed maturity date and cannot be terminated unilaterally by Ruffer.

INTENDED RETAIL INVESTOR

The product is targeted at Retail Clients, Professional Clients and Eligible Counterparties. The investor's objective for this investment should be aligned with that of the product as outlined above.

#### **COSTS OVER TIME**
