You are about to purchase a product that is not simple and may be difficult to understand

What is this product?

This PRIIP is a class of shares of the fund Blackstone / GSO Loan Financing Limited (the "Fund"). The Fund is a registered closed-ended investment company incorporated in Jersey with limited liability on 30 April 2014 under the laws of Jersey, with registered number 115628.

Type

The shares are traded on the Main Market of the London Stock Exchange. The Fund has an unlimited life and there is no maturity date for the shares. The return from an investment in the shares will be driven by the price at which the ordinary shares are sold compared to the original purchase price, and by any dividends paid by the Fund to the investors in its shares during the holding period. The Fund may, but is under no obligation to, repurchase shares and the shares are not redeemable at the investors' request; investors should expect that the primary means of disposing of shares will be by sales on the secondary market. The price at which an investor may dispose of shares will depend on the prevailing secondary market price, which may, or may not, reflect the prevailing net asset value per share.

Objectives

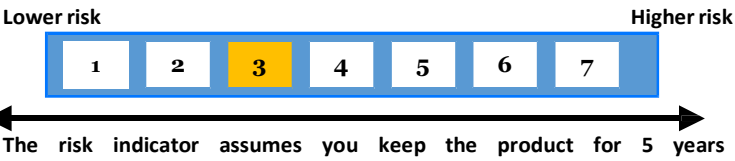
The Fund's investment objective is to provide shareholders with stable and growing income returns, and to grow the capital value of the investment portfolio by exposure predominantly to floating rate senior secured loans directly and indirectly through CLO Securities and investments in loan warehouses. The Fund seeks to achieve its investment objective through exposure (directly or indirectly) to one or more risk retention companies or entities established from time to time.

Intended retail investor

The target market for this product is high-net-worth investors, private client fund managers and brokers and other retail investors who are capable of evaluating the merits and risks of such an investment and/or who have received advice from their fund manager or broker regarding such an investment. The product is only suitable for investors: (i) who understand the potential risk of capital loss and that there may be limited liquidity in the underlying investments of the Fund; (ii) who have sufficient resources to be able to bear losses (which may equal the whole amount invested) that may result from such an investment, (iii) for whom an investment in the Fund's shares is part of a diversified investment programme; and (iv) who fully understand and are willing to assume the risks involved in such an investment programme.

What are the risks and what could I get in return?

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions could impact the capacity to pay you.

PRESENTATION OF COSTS
