What is this Product?

Ordinary Shares in Asia Dragon Trust plc, an actively managed investment company registered in Scotland and listed on the London Stock Exchange. The Company aims to achieve long-term capital growth through investment in Asia excluding Japan and Australasia. Investments are made primarily in stock markets in the region, principally in large companies. When appropriate, the Company will utilise gearing to maximise long term returns. The Company has borrowed to purchase assets. The Company does not have a fixed life but shareholders have the opportunity to vote for the continuation of the Company every 3 years. Further, in certain other circumstances the Company may be wound up following a proposal from the directors and its approval by the shareholders, subject to compliance with relevant legal and regulatory requirements. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Company. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. What are the risks and what could I get in return?

What are the costs?

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment.
