You are about to purchase a product that is not simple and may be difficult to understand.

### What is this product?

Type: The Company is a closed-ended investment company whose ordinary shares are listed on the London Stock Exchange and an

alternative investment fund under the Alternative Investment Fund Managers Directive, incorporated in the United Kingdom. The Company's ordinary shares are therefore available to the general public. The Company's website can be found at

Objective: The Company's objective is to provide shareholders with consistent long-term returns in excess of the FTSE All-Share Index by

investing predominantly in unquoted companies where value can be created through strategic and operational change. The Company will pursue its investment objective by investing, directly or indirectly, in a portfolio of unlisted companies where the Manager believes it can add value through organic growth, operational improvements, margin expansion, reorganisation or by

acquisition to achieve scale.

Intended retail The Company is suitable for all investors seeking a fund that aims to deliver growth with a long-term horizon as the core or a

investor: component of a portfolio of investments. The investor should be prepared to bear losses and accept the risks inherent in the

Company's investment policy. The Company is suitable for mass market distribution.

Bid/Offer spread: Shares of the Company are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a share

will be higher than the price at which you could sell it.

Gearing: The Company has the ability to borrow and to charge its assets as security. The Company may borrow no more than twice the

Company's share capital and reserves, allowing for the deduction of debit balances on any reserves. This will magnify any gains or

losses made by the Company.

#### What are the risks and what could I get in return?

## What happens if HgCapital Trust plc is unable to pay out?

## What are the costs?
