

What is this product?

Туре:	Aberforth Split Level Income Trust plc (the Company) is an investment trust whose shares are listed on the London Stock Exchange and an Alternative Investment Fund under the Alternative Investment Fund Managers Directive.
Objective and key points:	The Company's objective is to provide Ordinary shareholders with a high level of income, together with the potential for income and capital growth, and to provide Zero Dividend Preference (ZDP) shareholders with a pre-determined final capital entitlement of 127.25p on the planned winding up date of 1 July 2024, by investing in a diversified portfolio of securities issued by small UK quoted companies. The Company's shares are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it. The Company was launched on 3 July 2017 and has a planned winding up date of 1 July 2024. The Company's Ordinary shares are geared by the capital entitlement of the ZDP shares. This will magnify any gains or losses made by the assets attributable to the Ordinary shares. The ZDP shares had a gross redemption yield of 3.5% at launch, based on the issue price of 100p. ZDP shareholders do not receive any dividends.
Intended retail investor:	This product is suitable for investors planning to hold an investment for the medium to long-term (until the planned winding up date of 1 July 2024) and is designed to be used as one component in an investment portfolio – potential investors in the Company's Ordinary shares are advised to consult their professional investment advisers in respect of any investment

decision in relation to those shares.

What are the risks and what could I get in return?



Lower risk

The risk indicator assumes you hold your investment for 4 years. The actual risk can vary significantly if you sell your investment within a shorter timeframe and you may get back less. You may not be able to sell your investment easily, or may have to sell at a price that significantly impacts on how much you get back.

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as class 6 out of 7, which is a high risk class.

This classifies the potential volatility from future performance at a high level, and poor market conditions are likely to impact the capacity for you to receive a positive return on your investment. This classification is based on the volatility of the product's share price returns over 3 years.

Investments in shares of smaller companies are generally considered to carry a higher degree of risk. The performance of shares of smaller companies may be more volatile than the shares of larger companies over short time periods.
