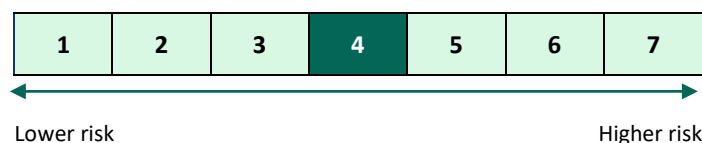

What is this product?

Type:	Genesis Emerging Markets Fund Limited (the 'Fund') is a Guernsey registered Closed-Ended Investment Company. The Fund's shares are listed on the premium segment of the Official List of the UK Listing Authority and are traded on the London Stock Exchange.
Objectives:	This product aims to achieve long-term capital growth primarily through investments in listed equity markets of developing countries in Asia, Latin America, Africa and Eastern Europe. The Fund invests in a diversified set of approximately 120 companies across more than 30 emerging markets (and typically including a number of smaller companies operating in less-developed countries).
Intended Investor:	This product is intended for investors: i) who are able to bear a total loss of capital; ii) who have a long-term investment horizon of 5 years or more; iii) who have at least an average knowledge of relevant financial products, and/or some experience with the financial industry; and iv) who are seeking a capital growth objective through investment in emerging markets.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily, or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are unable to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class.

This classifies the potential volatility from future performance at a medium level and poor market conditions are likely to impact the capacity for you to receive a positive return on your investment. Overall Fund performance may be affected by a number of different types of risk; these are explained further in the Fund's Annual Report which can be found on its website, www.genesisemf.com. This product does not include any protection from future market performance, so you could lose some or all of your investment.
