### What is this product?

## Type

The Trust is an investment company as defined in Section 833 of the Companies Act 2006 and operates as an investment trust in accordance with Section 1158 of the Corporation Tax Act 2010. The Company is subject to the UK Listing Authority Rules.

# **Objectives**

Invests in a prudently diversified selection of both well known and smaller companies to provide investors with a high dividend income stream while also maintaining the prospect of capital growth. A substantial majority of the company's assets are currently invested in ordinary shares of listed companies with the balance in listed fixed interest stocks. The Company invests predominately in companies listed in the UK and does not expect to invest more than 20% of total assets in non-UK listed companies. The Company has an active policy of using appropriate levels of gearing. The gross level of borrowings at drawdown will not be greater than 40% of the total values of the Company's investments.

# Intended retail investor

Investors (retail, professional and eligible counterparties) with at least basic capital markets knowledge or experience of shares, who understand the Trust's risks, seeking income from well known and smaller UK companies, and intend to invest their money for at least five years. This Trust is designed to be used only as a component in a diversified investment portfolio and is not designed for investors who are unable to accept more than a minimal loss of their investment.

# **Terms of the PRIIP**

This investment has no maturity date. There are no circumstances under which Janus Henderson would be entitled to terminate the Company unilaterally. There are no circumstances under which the Company can be automatically terminated.
