What is this product?

investor:

Type: This product is a physically backed exchange traded commodity. These are

secured, limited recourse certificates.

Objectives: The Invesco Physical Gold P-ETC aims to provide the performance of the spot

gold price through certificates collateralised with gold bullion.

The product includes a foreign exchange hedge to reduce the exposure of the certificates to exchange rate fluctuations between GBP and USD, the currency

in which the underlying precious metal is typically quoted.

The base currency is GBP.

Intended This product is intended for investors who (i) have sufficient knowledge and

experience to make a meaningful evaluation of the merits and risks of investing in the certificates; (ii) are willing to invest for a medium to long term; and (iii) have financial resources to bear all the risks associated with this product

including loss of original capital.

Maturity: This product is open ended. The Issuer has the right to terminate the product in

a limited number of circumstances, as set out in the prospectus.

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
