WisdomTree Short EUR Long GBP 3x Daily is designed to enable investors to gain a 'leveraged short' exposure to Euro ("EUR") relative to Pounds Sterling ("GBP") by tracking the MSFX Triple Short Euro/GBP Index (TR) (the "Index"), which aims to reflect three times the performance of a position in forward contracts which are rolled on a daily basis. The product provides a three times short exposure to EUR relative to GBP. For example, if EUR were to rise in value relative to GBP, the Index (tracked by the ETC) would decrease in value by three times the same amount. Conversely if EUR were to decrease in value relative to GBP, the Index would increase in value by three times the same amount. The Index return also includes a component based on the interest rate differentials, reflecting the difference between the EUR and the GBP exchange rates. The Index is a total return Index, which means that it also provides a collateral yield. For periods of longer than one day, the return of the Index is not the same as the performance of a position in forward contracts multiplied by a factor of minus three (the "Leverage Factor").
