What is this product?

Type

The Company's shares are listed on the premium segment of the Official List of the UK Listing Authority ('UKLA') and are admitted to trading on the main market of the London Stock Exchange.

Objectives

Aims to achieve income generation and capital growth while seeking a lower level of portfolio volatility than conventional equity portfolios. The Company will invest in a diversified global portfolio of securities and other assets including equities, equity-linked securities, fixed income securities, alternative assets and derivatives. The Company typically invests directly although it may take positions in pooled vehicles. Returns are typically determined by the performance of investments made by the Company. The Company may gear the portfolio up to 20% in normal market conditions. Gearing may magnify gains or losses experienced by the Company.

Intended retail investor

The Company is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for long-term investment. Investors should understand the risks involved, including the risk of losing all capital invested and must evaluate The Company's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances. Shares in The Company are not intended as a complete investment plan.

What are the costs?
