#### **Objectives**



The Company may gear the portfolio up to 20% in normal market conditions. Gearing may magnify gains or losses experienced by the Company.

#### Intended retail investor

The Company is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for long-term investment. ### What are the costs?
