What is this product?

Type

The Company's shares are listed on the premium segment of the Official List of the UK Listing Authority ('UKLA') and are admitted to trading on the main market of the London Stock Exchange.

Objectives

Aims to achieve capital growth from North American investments by outperformance of The Company's benchmark, the S&P 500 Index expressed in sterling total return terms. It emphasises capital growth rather than income. The Company will predominantly invest in the shares of larger quoted companies alongside a holding of up to 10% in smaller capitalisation quoted companies. The Company typically invests directly although it may also take positions in pooled vehicles to gain exposure to such companies. Returns are principally determined by the performance of the investments made by The Company, although The Company typically gears the portfolio within the range of 5% net cash to 20% geared in normal market conditions. Gearing may magnify gains or losses experienced by The Company.

Intended retail investor

The Company is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for long-term investment. Investors should understand the risks involved, including the risk of losing all capital invested and must evaluate The Company's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances. Shares in The Company are not intended as a complete investment plan.

The Company has been established with an unlimited life.

Risks

What happens if JPMorgan Funds Limited is unable to pay out?

What are the costs?
