What is this product?

Type

Objectives



Returns are principally determined by the performance of the investments made by The Company, although The Company has the ability to use borrowing to gear the portfolio to up to 15% of net assets where appropriate. Gearing may magnify gains or losses experienced by The Company.

Intended retail investor

The Company is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for long-term investment. Investors should understand the risks involved, including the risk of losing all capital invested and must evaluate The Company's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances. What are the costs?
