What is this Product?

Ordinary Shares in Aberdeen New India Investment Trust PLC, an actively managed investment company registered in England and listed on the London Stock Exchange. Its investment objective is to achieve long-term capital appreciation by investment in companies which are incorporated in India, or which derive significant revenue or profit from India, with dividend yield from the company being of secondary importance. The Company may borrow to purchase assets. The Company does not have a fixed life but shareholders are given the opportunity to vote on the continuation of the Company annually. Further, in certain other circumstances the Company may be wound up following a proposal from the directors and its approval by the shareholders, subject to compliance with relevant legal and regulatory requirements. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Company. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. What are the risks and what could I get in return?

What happens if the Company is unable to pay out?

What are the costs?

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment. Since the value of investments and the income from them can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type.
