## What is this product?

#### Туре

The Company's shares are listed on the premium segment of the Official List of the UK Listing Authority ('UKLA') and are admitted to trading on the main market of the London Stock Exchange.

#### Objectives

Aims to provide shareholders with long-term total returns, predominantly comprising capital growth but with the potential for income, by investing primarily in Brazilian focused companies. The Company may also invest up to 10% in companies in other Latin American countries. The Company typically invests directly although it may also take positions in pooled vehicles to gain exposure to such companies. Equity holdings may be reduced to a minimum of 60% of gross assets if it is considered beneficial to performance. Returns are principally determined by the performance of the investments made by the Company.


#### Intended retail investor

The Company is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for long-term investment. ## What are the costs?
