What is this product?

Type

This product is an investment trust company, which is a type of alternative investment fund.

Objectives

- The Company aims to achieve long term growth in both capital and income by predominantly investing in equities (and their related securities) of continental European companies.
- The Investment Manager will typically focus on larger companies which show good prospects for sustainable long term dividend growth.
- The Investment Manager is not restricted in terms of size, industry or geographical split.
- The Company may also invest into other transferable securities, investment companies, money market instruments, cash and deposits and is also able to use derivatives for efficient portfolio management, to gain additional market exposure (gearing) and for investment purposes.

Intended retail investor

This product is open for an unlimited duration, however, continuation votes are held every three years at the Company's Annual General Meeting.
