You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Debt security Type:

ETFS 3x Daily Long FTSE 100 is designed to enable investors to gain a three times daily leveraged 'long' Objectives:

exposure to FTSE 100 Net of Tax (FTSE 100) by tracking the FTSE 100 Daily Super Leveraged RT TR Index (the "Index"). A daily leveraged long exposure means that the Index and the product are designed to reflect three times the daily percentage change in the Underlying Index. For example, if the Underlying Index was to rise in value by 5% on a particular day, the Index and the product would increase in value by 15% on that day (before fees, expenses and adjustments) and if the Underlying Index were to fall in value by 5% on a particular day, the Index and the product would decrease in value by 15% on that day (before fees, expenses and adjustments). For periods of longer than one day, the return of the Index is not the same as the return of the Index multiplied by a factor of three (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Index on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Underlying Index, the more the performance of the Index will deviate from the performance of the Index (multiplied by the Leverage factor) over a given period of time. The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Societe Generale. The payment obligations of the swap counterparty to the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.
