What is this Product?

The information contained in this document and the methodologies for calculating risks, costs and potential returns are prescribed by EU rules.

The Company is a closed-ended investment company whose shares are listed on the London Stock Exchange and an alternative investment fund under the Alternative Investment Fund Managers Directive ("AIFMD"). The Company's shares are therefore available to the general public.

The objective of the Company is to provide income and capital growth over the long term.

The Company aims to achieve its objective by investing in a portfolio of shares in companies and other asset classes such as corporate and government debt securities but will focus on UK companies with the potential for dividend growth. The Company additionally has the flexibility to invest in the shares of companies not listed or traded on a stockmarket. Investments in such companies will not, in aggregate, exceed 5% of the value of the Company's investment portfolio at the time of investment.

The portfolio does not track any benchmark index, which means that the manager is not constrained to particular industry sectors and has a wider investment universe to choose from.

The Company has the ability to borrow up to 15% of the Net Asset Value of the Company. Where a borrowing facility is used, this will have the effect of magnifying any gains or losses made by the Company.

The target investors are institutions and individual retail investors

There is no fixed maturity date. There is no ability for the Company to terminate shareholdings of investors in the Company unilaterally or automatically. Shareholders can vote on an annual basis for the continuation of the Company as an investment trust. If shareholders vote in a simple majority against continuation, the Board would have to put forward a proposal for the future of the Company, which could include liquidation.

The shares of the Company are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

The risk indicator assumes you keep the product for 5 years. If you sell the shares at an earlier stage the actual risk can vary significantly, which may mean you get back less.

We have classified this product as 4, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the amount you could get back.

How long should I hold it and can I take money out early?

Whilst the shares are traded on the main market, it is possible that there may not be a liquid market in the shares and investors may have difficulty selling them.
