

## What is this product?

<b>Type</b>	This product is a closed-ended investment scheme listed on the Main Market of the London Stock Exchange (within the Specialist Fund Segment).
<b>Strategy</b>	The aim of the product is to provide Shareholders with attractive risk adjusted returns, principally in the form of regular, sustainable dividends, through investment predominantly in a range of secured loans and other secured loan-based instruments originated through a variety of channels and diversified by way of asset class, geography and duration.
<b>Intended</b>	This product is designed for investors who are seeking exposure to alternative finance investments and related Investor instruments and who are capable themselves of evaluating the merits and risks of the investment and who have sufficient resources to bear any loss which may result from such an investment.
<b>Maturity</b>	This product has an unlimited life, however in the event that the Ordinary Shares have been trading at a discount to NAV of greater than 10% for three consecutive months (calculated on a rolling three monthly average of daily numbers), the Board shall convene a general meeting to propose a continuation resolution. If such a continuation resolution is not passed, the Board will draw up proposals for the winding-up or reconstruction of the fund for submission to Shareholders.

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this fund compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions could impact our capacity to pay you.

The following are some of the other risks materially relevant to the PRIIPs which are not taken into account in the summary risk indicator:

The fund is exposed to exchange rate volatility as it holds assets denominated in multiple currencies. We endeavour to mitigate foreign exchange risk by conducting hedging operations. See prospectus for overall risk information.
