#### What is this Product?

Ordinary Shares in Aberdeen Latin American Income Fund Limited, an actively managed investment company registered in Jersey and listed on the London Stock Exchange. The investment objective is to aim to provide investors with exposure to the above average long-term capital growth prospects of Latin America combined with an attractive yield, primarily through investing in the shares of Latin American companies and bonds issued by governments and companies in the region. The Company has borrowed to purchase assets. The Company does not have a fixed life. Aberdeen Standard Capital International Limited may not unilaterally terminate the Ordinary Shares however the Company may be wound up with shareholder approval. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. ## How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment.
