#### What is this Product?

Ordinary Shares in Murray International Trust PLC, an actively managed investment company registered in Scotland and listed on the premium segment of the London Stock Exchange. Its investment objective is to achieve a total return greater than its benchmark by investing predominantly in equities worldwide. Within this objective, the Manager will seek to increase the Company's revenues in order to maintain an above average dividend yield. The Company's assets are invested in a diversified portfolio of international equities and fixed income securities spread across a range of industries and economies. The Company has borrowed to purchase assets. The Company does not have a fixed life. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Ordinary Shares however the Company may be wound up with shareholder approval. Shares in the Company are bought and sold on a stock market, namely the London Stock Market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. ## What are the risks and what could I get in return?

## What are the costs?

## How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment.
