Coupon:

On each Coupon Observation Date, if the level of the Reference Underlying is at or above the Coupon Barrier, you will receive on the payment date: The Coupon multiplied by the number of years the product has elapsed since inception, minus the sum of coupons already paid. Final Redemption :

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended Holding Period: 1 year 3 months 3 days
