Final Redemption :

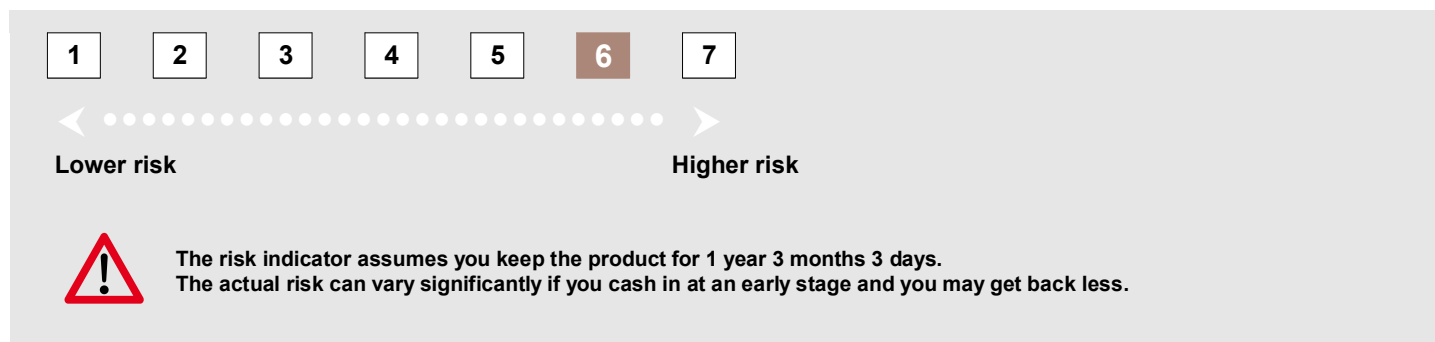

### Summary Risk Indicator

#### Recommended Holding Period: 1 year 3 months 3 days
