## What is this product?

Type Hansa Investment Company Ltd has two classes of shares: these, the Ordinary shares, and the

other, the 'A' non-voting Ordinary shares. They have the same financial interest in the underlying assets of the Company and receive the same dividend but differ only in that these shares have voting rights, whereas the latter do not. They trade separately on the London Stock Exchange,

giving rise to different share prices at any given time.

**Strategy** The objective of the Company is to invest in a portfolio of quoted and unquoted special situations,

many of which may not normally be available to the general public, with the objective of achieving growth of shareholder value. By the very nature of special situation investments, the opportunity to invest in them will arise at any time but often not for long periods. Sometimes a number of opportunities may arise at the same time. Any single investment may, on occasion, constitute a significant proportion of the portfolio and/or that of the company concerned. The investment strategy of the Company has evolved over time, but it has always been managed with

a strong focus on seeking out undervalued investments.

**Intended Investor** The target investors are institutions and individual retail investors.

Maturity There is no fixed maturity date. There is no ability for the Company to terminate shareholdings of

investors in the Company unilaterally or automatically.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The summary risk indicator is a guide to the level of risk of this product compared to other products.
