What is this Product?

Ordinary Shares in abrdn New Dawn Investment Trust PLC, an actively managed investment company registered in England and listed on the London Stock Exchange. Its investment objective is to provide shareholders with a high level of capital growth through equity investment in the Asia Pacific countries ex Japan. The Company has borrowed to purchase assets. The Company does not have a fixed life but has a continuation vote linked to the discount at which the Company's shares trade to their net asset value in the 90 days preceding it's financial year end. Further, in certain other circumstances the Company may be wound up following a proposal from the directors and its approval by the shareholders, subject to compliance with relevant legal and regulatory requirements. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Company. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. What are the risks and what could I get in return?

What happens if the Company is unable to pay out?

What are the costs?

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment.
