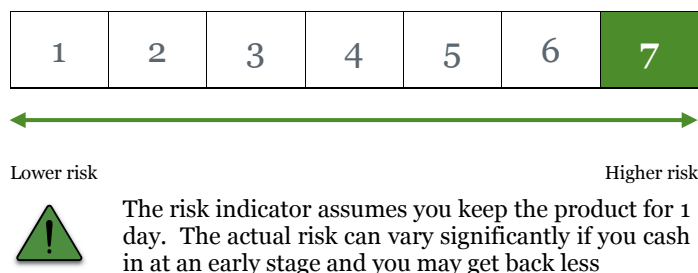
What is this product?

Type: Debt security

Objectives: ETFS 3x Daily Long Nickel is designed to enable investors to gain a three times 'leveraged' exposure to a total return investment in nickel futures contracts by tracking the Bloomberg Nickel Subindex (the "Index") and providing a collateral yield. A daily leveraged long exposure means that the product is designed to reflect three times the daily percentage change in the Index. For example, if the Index was to rise in value by 5% on a particular day, the product would increase in value by 15% on that day (before fees, expenses and adjustments) and if the Index were to fall in value by 5% on a particular day, the product would decrease in value by 15% on that day (before fees, expenses and adjustments). For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of three (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Index on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Index, the more the performance of the product will deviate from the performance of the Index (multiplied by the Leverage factor) over a given period of time. The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Citigroup Global Markets Limited and Merrill Lynch International. The payment obligations of the swap counterparties to the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.

Intended retail investor: The product is intended for informed retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering a leveraged exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.

What are the risks and what could I get in return?



Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified the risk classes of the underlying investment strategies as 7 out of 7

This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact the performance.

Be aware of currency risk. If the trading currency is different to the base currency, you will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Costs over Time
