What is this product?

Type: Objective:	This product is an investment trust. The company aims to achieve above-average rates of total return over the longer term and a growing dividend stream.			
	 The company's portfolio is actively managed and comprises largely UK equities, with selected overseas investments. The investment manager takes a stock-specific approach in managing the portfolio and, therefore, sector weightings are of secondary consideration. As a result of this approach the portfolio will not track any stockmarket index. There is no restriction on the number of investments that can be held in the portfolio. 			
	 The company also invests in unquoted companies. On acquisition, no holding shall exceed 30% of net assets. For the purpose of measuring this, unquoted investments will be measured by the lower of their cost or current valuation. In addition, the company can invest up to 30% of its net assets in hedge funds and/or other unregulated collective investment schemes.

Intended investor:	This product is intended for investors who are willing to invest for a medium to long term and who plan to stay invested for at least 5 years.
