What is this product?

Type

The Trust is an investment company as defined in Section 833 of the Companies Act 2006 and operates as an investment trust in accordance with Section 1158 of the Corporation Tax Act 2010. The Company is subject to the UK Listing Authority Rules.

Objectives

To provide a growing total annual dividend, as well as capital appreciation by investing in focused and internationally diversified portfolio of 50-80 companies that either listed in, registered in, or whose principal business is in countries that are outside the UK. The portfolio is made up of shares (equity securities) and fixed interest asset classes that are diversified by factors such as geography, industry and investment size. The Company may use financial instruments known as derivatives for the purposes of efficient portfolio management or investment purposes or to generate additional income. The Company can borrow to make additional investments with the aim of achieving a return greater than the cost of borrowing. The Company's articles allow borrowing up to 100% of net assets, but in normal circumstances the manager may only utilise gearing of up to 25% of net assets.

Intended retail investor

Investors (retail, professional and eligible counterparties) with at least basic capital markets knowledge or experience of shares, who understand the Trust's risks, seeking dividends and capital appreciation from companies outside the UK, and intend to invest their money for at least five years. This Trust is designed to be used only as a component in a diversified investment portfolio and is not designed for investors who are unable to accept more than a minimal loss of their investment.

Terms of the PRIIP

This investment has no maturity date. There are no circumstances under which Janus Henderson would be entitled to terminate the Company unilaterally. There are no circumstances under which the Company can be automatically terminated.
