What is this product?

Туре	The Company is a closed-ended investment company within the meaning of Section 833 of the Companies Act 2006 whose shares will be listed on the London Stock Exchange. It is an alternative investment fund under the Alternative Investment Fund Managers Directive. The Company's ordinary shares are therefore available to the general public.	
Objectives	The Company's objective is to seek total returns principally through capital growth over a medium to long-term period through investment in companies predominantly in the United Kingdom.	
Intended retail investor	The intended investor in the Company is a retail investor who is seeking long term (at least 5 years) real growth in capital value from investing in UK equities. An investment in the shares of the company is only suitable for investors who are capable of evaluating the potential benefits of investment and have sufficient resources to bear any loss suffered by the investment. The product aims to produce returns principally through capital and therefore this product may not be suitable for investors looking for regular income through dividends.	
Gearing	The Company will have no gearing.	
Bid / Offer spread	Shares of the Company are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it.	
Continuation	The Company does not have a fixed life. The Manager cannot unilaterally terminate this product and there are no circumstances under which it can be automatically terminated.	

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years. If you sell your product earlier you may have to sell at a price that significantly impacts how much you get back.

Performance Scenarios

How long should I hold it and can I take money out early?

Recommended required minimum holding period: 5 years

The product has no required minimum holding period but is designed for medium to long-term investment. The recommended minimum holding period of 5 years has been selected as the Company's ordinary shares are designed to be held over the long term and may not be suitable as short-term investments.

There is no guarantee that any appreciation in the value of the Company's investments will occur and investors may not get back the full value of their investments. The value of the ordinary shares and the income derived from them (if any) may go down as well as up. Although the ordinary shares are traded on the Main Market, it is possible that there may not be a liquid market in the shares and investors may have difficulty selling them. Accordingly, investors may be unable to realise their shares at the quoted market price (or at the prevailing net asset value per share), or at all.

There are no additional fees or penalties incurred on exit, however the price you receive on the open market may not reflect the underlying NAV of the shares.
