

ETFS Physical Silver is designed to enable investors to gain a simple and cost-efficient way to access the silver market by providing a return equivalent to the movements in the silver spot price less the applicable management fee. The product reflects the performance of the underlying spot price such that, for example, if the spot price were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the spot price were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. This ETP is backed by physical allocated Silver held by an independent custodian, HSBC Bank plc. Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery for gold and silver can be accepted by the custodian. Each physical bar is segregated, individually identified and allocated.
