What is this product?

Objectives

The objective of this product is to provide three times the daily performance of the Emerging Equities Rolling Futures Index (the "Benchmark"), which tracks Front Quarter and Second Quarter mini MSCI Emerging Markets Index futures, plus the interest revenue earned on the collateralised amount.
