What is this Product?

Ordinary Shares in The North American Income Trust plc, an actively managed investment company registered in Scotland and listed on the London Stock Exchange. Its investment objective is to provide an above-average dividend income and long-term capital growth, through investment in a portfolio consisting predominantly of North American companies (listed on the S&P 500 Index). The Company has borrowed to purchase assets. The Company does not have a fixed life but shareholders have the opportunity to vote on the continuation of the Company every 3 years. Further, in certain other circumstances the Company may be wound up following a proposal from the directors and its approval by the shareholders, subject to compliance with relevant legal and regulatory requirements. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Company. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment.
