What is this product? _{Type}	Ordinary shares in a public company incorporated in the United Kingdom. Save for payments of dividends made in accordance with its dividend policy from time to time or other returns (e.g. on a winding up), the Company is not expecting to pay you and you are expected to generate returns through selling your shares through a bank or stockbroker. The ordinary shares have no maturity date. Shares of the Company are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it.
Objectives	The Company's investment objective is to provide shareholders with an attractive level of dividend income and capital growth through investments in credit assets and equity assets that are aligned with the Company's strategy and that present opportunities to enhance the Company's returns from its investments. 
What are the risks and what could I get in return?

Risk indicator

What happens if Pollen Street Secured Lending plc is unable to payout?

As a shareholder of Pollen Street Secured Lending plc you would not be able to make a claim to the Financial Services Compensation Scheme nor any other compensation body about the Company in the event that the Company were unable to pay any dividends or other returns it may elect to pay from time to time, or if it were unable to pay any amounts due to you on a winding up at the end of its life. What are the costs?

Presentation of Costs

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000. The figures are estimates and may change in the future.

The Performance Scenarios above are shown based on share price returns together with returns from dividends or other distributions net of estimated costs. How long should I hold it and can I take money out early?

Recommended holding period: 5 years
