What is this product?

Type

This product is a closed-ended investment company, incorporated as a public limited company in England and Wales. The Company has investment trust status. The Company's Shares are listed and traded on the London Stock Exchange.

Objectives

The Company aims to achieve long term capital growth by investing in a diversified portfolio of technology companies from around the world. The Manager may use financial derivatives (complex instruments based upon the value of underlying assets) to help achieve the Company's investment objective and to manage exposure to risk.

Intended investor

Shares in the Company are offered to investors who are prepared to risk their capital up to the amount invested in the Company. Investors should be prepared to stay invested for the long term. Shares in the Company should be held as part of a diversified portfolio of investments.

Term

Shareholders can vote on whether the Company should continue in operation at every fifth Annual General Meeting ("AGM") of the Company. Such a resolution was proposed at the AGM on 9 September 2015 and passed with 99.9% of the votes cast in favour of continuing for a further five years. The next continuation vote will be proposed at the AGM in 2020.

What are the risks and what could I get in return?

The summary risk indicator below is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.



The risk indicator assumes you keep the product for five years. The actual risk can vary significantly if you sell your Shares at an early stage and you may get back less than you invested. You may not be able to sell your Shares easily or you may have to sell at a price that significantly impacts on how much you get back.

We have classified this product as 4 out of 7, which is classed as medium risk. This rates the likelihood of losing money in the future, based on historic prices, as medium. In periods when market conditions are poor, the value of your investment may fall, and this may impact the amount you get back in the long term.

As the shares are not traded directly with the Company or the Manager but are traded on the London Stock Exchange, any default by the Manager will not materially affect the value of your shares. As the shares are listed on the London Stock Exchange, any direct holding of these shares is not covered by any investor compensation schemes in relation to either the Manager or the Company.

What are the costs?
