What is this product?

Type: Non Cellular Company Limited by Shares

Objectives: This product targets income generation whilst seeking to preserve investors' capital and give protection against rising interest rates. It aims to provide regular dividends whilst preserving the capital value of its investment portfolio. The portfolio seeks to provide a stable level of income whilst also seeking to preserve underlying capital. However, due to the dynamics of loan securities and the illiquidity that they can face, we do not feel that this product would explicitly be suitable for those investors that have a sole target of capital preservation. The portfolio managers typically take an approach of high quality senior secured listed loans. Through the investments in loan securities the product will typically grow its capital through the appreciation of those positions. With this in mind we feel that it is prudent for the advisor or distributor to determine whether the fund is appropriate for investors who seek to obtain capital growth as their objective.

The product's portfolio managers seek to generate yield by investing in mainly floating rate senior secured loans issued in US Dollars, GBP and Euro. These loans are often below investment grade senior secured corporate loans. This product also makes selective use of senior bonds on an opportunistic basis, diversified by both borrower and industry.

The portfolio managers of this product will generally seek to focus on issuers that have the ability to generate cash flow through a full business cycle, maintain adequate liquidity, possess an enterprise value in excess of senior debt and have access to both debt and equity capital.

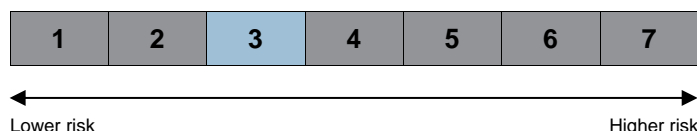
This product is designed to form part of a portfolio of investments.

Intended Investor: This product is only suitable for institutional, professional and high net worth investors, private client fund managers and brokers who are capable of evaluating the merits and risks who plan to stay invested until the end of the recommended holding period and can bear loss of capital. An investor with reasonable knowledge of loans would need to be assessed by the advisor or distributor to establish suitability for this product.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. The risk indicator assumes you keep the product for 5 years.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to impact our capacity to pay you.

What are the costs?
