What is this Product?

Ordinary Shares in Aberdeen Emerging Markets Investment Company Limited, an actively managed investment company, registered in Guernsey and listed on the London Stock Exchange. Its investment objective is to achieve consistent returns for shareholders in excess of the MSCI Emerging Markets Net Total Return Index, in Sterling terms. The Company invests in a portfolio of funds and products which give a diversified exposure to developing and emerging market economies. The Company has borrowed to purchase assets. The Company does not have a fixed life but shareholders have the opportunity to vote for continuation every five years. Further, in certain other circumstances the Company may be wound up following a proposal from the directors and its approval by the shareholders, subject to compliance with relevant legal and regulatory requirements. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Company. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Company is not able to pay you.

What are the costs?

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment. Since the value of investments and the income from them can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type.
